Job Relationships: Reports to Senior Director and serves as a member of the leadership

team of the organization.

Job Summary: Provides medical care for all shelter cats from intake through post-

adoption. Performs physical exams, dispenses medications, and makes recommendations for outsourced diagnostics and procedures. Ensures that all shelter cats are adopted in great physical and emotional health.

Works with the Shelter Manager and her staff on designing and

implementing processes that facilitate comfort and ease of transition to

a home environment.

Responsibilities:

- Have respect for and willingness to work with shelter staff and all types of cats and kittens and a
 commitment to practicing the highest standard of medicine, upholding the veterinary code of
 ethics.
- Perform physical examinations and diagnostic/medical procedures in a way that will deliver the
 highest quality care while minimizing patient stress and discomfort and must be able to explain
 physical examination findings and communicate to the staff a diagnosis of the animal's problems
 and must generate and present a treatment plan for the animal.
- Develop and administer disease prevention for shelter animals which can encompass traditional medical practices such as vaccination, parasite control, and nutrition as well as areas less commonly considered such as air quality, facility design, enrichment, stress reduction and management of population density.
- May be asked to serve as a resource to assist Shelter Manager with protocols for sanitary measures, feeding, disease prevention and general care to promote quality healthcare for the animals.
- Assist in planning, organizing and implementing programs, including emergency preparedness and evacuation plans.
- Assist in creating Standard Operating Procedures (SOP).
- Authority to make medical decisions related to the care of shelter animals.
- Conduct and oversee exams for foster cats, hospice cats, and mature companion program cats.
- · Attend staff meetings.
- Ascribe to the no-kill philosophy of SAFE Haven for Cats.
- Other duties as assigned.
